277/19 APOLOGIES FOR ABSENCE

278/19 TO RECEIVE DECLARATION OF INTERESTS

Cllr Wood declared an interest in item 11.

280/19 A REMINDER TO ALL COUNCILLORS TO ADHERE TO THE CODE OF CONDUCT AND STANDING ORDERS.

All councillors reminded of the code of conduct and standing orders. A copy of each will be circulated to the councillors by the clerk.

281/19 UPDATE ON THE NEIGHBOURHOOD PLAN (CLLR CHEADLE)

Carried forward to the next meeting.

282/19 TO DISCUSS CONCERNS FROM A LOCAL RESIDENT WITH REGARD TO THE LIGHTING AND SAFETY ON THE CORNER AT CRAPSTONE GOING TOWARDS THE WAR MEMORIAL AND AT THE BUS SHELTER TO INCLUDE A REQUEST FOR A STREET LIGHT AT THE BUS SHELTER. (CLLR WOOD)

A site visit was carried out to look at the bus shelter and any lighting provisions that could be provided. MF brought a sample of a solar light. There are a number of large trees overhanging the bus shelter it is believed to be part of Dartmoor National Park. One of the trees is a large ash tree this is possibly being affected by Ash dieback. The clerk will contact DNP with regards to whether planning permission is required for the solar lights. It was **AGREED** by the Council that lights would be fitted to the bus shelter, providing that planning permission is not required.

283/19 TO DISCUSS CYCLE PARKING FACILITIES AT YELVERTON. (CLLR WOOD)

Yelverton is becoming a destination for cyclists, there is currently only for cycle stands by the notice board. It was felt that better bike parking provisions are required at Yelverton. Further investigation will be carried out with regard to different types of cycle stands also as to whether any funding would be available.

The parish council are still uncertain as to whether Dartmoor National Park would permit a bin in that location. The clerk will ascertain from DNP whether a bin would be allowed and if so whether it have to be

a specific type.

West Devon Borough Council have stopped cutting an area of land in Chapel Meadow as they do not own the land. The area is owned by Ken Farnham he has been contacted and is trying to find the agreement that he may have had with the West Devon confirming that they would cut the grass. Recently residents have had to pay to have the area cut.
